Application For A Transfer Of A Certificate Of Public Convenience And Necessity

Dear Applicants:

Thank you for taking the time to fill out an application with the Regulatory Commission of Alaska ("Commission"). Our regulations require that all *applications for a transfer of a certificate of public convenience and necessity* be filed electronically over the Commission's website. In addition to providing all of the information requested in APUC FORM PU 103, the application enclosed with this letter, all applications must include the following items:

- A proposed public notice describing the nature of the application, and that meets
 the language requirements set forth in <u>3 AAC 48.648(e)</u>. A template notice that
 generally meets Commission requirements is included with this application
 package.
- A purchase order that demonstrates you have arranged for your proposed public notice to be published in a newspaper of general circulation in the state. (A purchase order can be in the form of a receipt from the newspaper or an email from the newspaper stating that you have arranged for payment and publishing of the proposed notice.)

Note: <u>The applicants do not issue the final public notice</u>. The Commission will review the proposed notice filed with your application, make changes as necessary, and issue the final public notice using the purchase order you provide with your application package.

If you do not wish to complete any portion of the application, you will have to file a motion for waiver, separate from your application, that meets the requirements set forth in <u>3 AAC 48.805</u>

You can request that any portion of your application be made confidential by filing a separate petition for confidentiality that meets the requirements set forth in <u>3 AAC 48.045</u>

INSTRUCTIONAL FOOTNOTES

General:

this form is furnished for your convenience to be used primarily as a working draft. Your final typed application is to be submitted in an original and one conformed copy and should not include the instructional footnotes. However, the form itself may be used as the application if you prefer to do so. In that event, any blanks not otherwise filled in should be marked "Not Applicable" or "None" as appropriate.

The application should be prepared in sufficient detail to enable you to go forward at a hearing, on reasonable notice, on the data which has been submitted and to sustain the burden of proof. The Commission is desirous of avoiding delays in processing applications. To this end it is recommended that the application and exhibits be of sufficient scope and format to be the applicant's case-in-chief in the event the matter is set for hearing.

- 1/ Under AS 42.05.221(a) separate applications are required for each type of utility, i.e.: electric, gas, water, sewer, or telecommunications.
- An original and one conformed copy of the application are to be furnished. With each application relating to a certificate, the applicant shall pay the Commission a fee of \$50.00 which shall be deposited in the General Fund of the State (AS 42.05.661).
- 3/ A tentative statement may be furnished initially with complete data furnished within 6 months of the effective date of the transfer. See Plant Instructions of the applicable utility Uniform System of Accounts.

- 4/ Set forth whether (a) transferee is an individual proprietorship, partnership, or corporation, (b) the date of organization and location of principal office and (c) if a foreign corporation, the state of incorporation. The purpose of a tariff is two-fold, as it serves to protect the utility against unreasonable demands by the public, and conversely it protects the public against excessive charges or other abusive acts on the part of the utility.

To accomplish these purposes, however, the tariff should be as comprehensive as possible for your purpose. Probably the best composition of your tariff would be in two parts, the first setting forth the rules, regulations, and conditions under which your service is offered. The second part would set forth your rates, charges, and fees. Suggested items you may wish to include in the rules section are:

- 1. Authorization of rules
- 2. Customer information
- 3. Customer deposits (if any)
- 4. Adjustment of bills
- 5. Reasons for denying service
- 6. Customer complaints
- 7. Extension plan
- 8. Interruptions of service
- 9. Protective measures

The rate section of your tariff should set forth all the charges to which your customers may be subject.

The above is a sample of the Alaska Public Utilities Commission's approved format for the applicant's presentation of his tariff including rates, rules, and
