

Notice of Utility Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Chugach Electric Association, Inc. (Chugach) filed TA453-8 proposing to add a voluntary Green Energy Program (Program) to its tariff service offerings. The Green Energy Program will provide residential, small general, and large general service customers the opportunity to voluntarily support renewable energy through a premium paid on their monthly electric bills.

All amounts collected under the Program will first be used to purchase Renewable Energy Certificates (RECs) at a level chosen by the participating customer. Any additional funds above the level necessary for REC purchases and to satisfy program expenses will be used to develop renewable energy grant projects in Chugach's service area, with a focus on projects advancing non-profits and other entities provide public benefits.

Members who volunteer to participate in the program may select from three levels of support and the applicable monthly charge will be added to their bills. A sample of the proposed monthly payments is presented below:

Level	Monthly Payment		
	Residential	Small General Service	Large General Service
Low	\$3.00	\$5.00	\$100.00
Medium	\$6.00	\$10.00	\$200.00
High	\$9.00	\$20.00	\$400.00

If a customer elects to cancel participation in the program, cancellation of participation becomes effective on the customer's next meter read date. The bill for the period prior to such date will include the final monthly payment amount. Bills will not be prorated for partial months of participation.

This notice does not contain all requested revisions and the Commission may approve a rate or classification that varies from those proposed.
