

NOTICE OF PIPELINE APPLICATION

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that on February 28, 2018, Cook Inlet Pipe Line Company (CIPL) and Swanson River Oil Pipeline, LLC (SROP) filed a joint application seeking Commission approval to connect a **segment of CIPL's oil pipeline** to SROP and for the approval of the proposed Connection Agreement between CIPL and SROP for the connection. Docket No. P-18-007 was opened to address this matter.

The joint applicants propose to connect CIPL E 10 segment of the CIPL oil transportation system to SROP. The Connection Agreement memorializes the intended arrangement between CIPL and SROP to connect the CIPL E 10 line to SROP at a location on the east side of Cook Inlet, **near SROP's junction** with Kenai Pipe Line Company in Nikiski.

No motions for waiver or petitions for confidentiality were filed with the application. The Commission has not assessed the completeness of the application. The Commission may determine the application is complete by March 21, 2018.


