

**Notice of Petition for Advance Determination of Decisional Prudence and  
Assurance of Cost Recovery for Redundancy Project**

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that a petition filed by Cook Inlet Natural Gas Storage Alaska, LLC (CINGSA), for advance determination of decisional prudence and assurance of cost recovery for the Redundancy Project. CINGSA currently provides natural gas storage services under Certificate of Public Convenience and Necessity (Certificate) No. 733. Docket U-18-024 was opened to address this matter.

The Redundancy Project includes three components: (1) the drilling of two additional storage wells plus the addition of a velocity string in one existing well; (2) the installation of an additional dehydration process train; and (3) the installation of a new turbine compressor unit. CINGSA currently estimates that the net aggregate cost of the Redundancy Project will be approximately \$41.0 million.

The petition requests that the Commission issue findings that CINGSA is acting prudently and in the public interest. CINGSA is requesting the Commission issue assurances that will allow CINGSA to recover costs from the Redundancy Project via future rate filings.
