

### Notice of Utility Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Cook Inlet Natural Gas Storage Alaska, LLC (CINGSA) filed TA32-733, a revenue requirement study based on a 2017 test year and depreciation study based on a 2016 test year. With this filing, CINGSA requests permanent rates, effective July 1, 2018. A selection of the current and proposed rates are in the table below.

CINGSA also proposed to introduce new rules for the crediting of ISS revenues to FSS customers. CINGSA proposes that it will share 50 percent of certain ISS revenues collected with its FSS customers on a monthly basis. The ISS revenues eligible to be shared will be those revenues collected under the ISS Rate and ISS Injection/Withdrawal Rate set out in Section 35.2 of its tariff.


