ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE PETITION FOR CONFIDENTIAL TREATMENT AND TIME TO FILE OPPOSITION

On October 5, 2020, the Attorney General, Regulator Affairs and Public Advocacy (RAPA) filed the prefiled testimony of Janet K. Fairchild-Hamilton, Jennifer L. Mainor, and Fiona K. Yiu. This testimony contains information and materials provided by Alaska Waste during discovery and is marked as confidential. Pursuant to the discovery order in docket, Alaska Waste has five business days to petition to have information and materials in RAPA's prefiled testimony classified as confidential. The five days expire on October 12, 2020.

On Friday, October 9, 2020, Alaska Waste filed a motion requesting an additional ten (10) calendar days to file its petition for confidential treatment along with a petition for expedited consideration. Alaska Waste states it will file its petition on or before October 22, 2020, and that it has contacted RAPA and RAPA does not oppose its motion.

Alaska Waste states that RAPA also requests an extension to reply to Alaska Waste's petition for confidentiality, if we grant the extension. Alaska Waste does not oppose RAPA's request.

I grant the petition for expedited consideration. I grant Alaska Waste's motion for an extension of time for it to file a petition for confidential treatment and for RAPA to file an opposition. Alaska Waste shall have until October 22, 2020, to file a petition for confidential treatment in accordance with the discovery order. I grant RAPA's request. RAPA shall have until October 30, 2020, to file its opposition.
