

Notice of Resale Agreement Adopted By Negotiation

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that ACS of Anchorage, LLC (ACS-AN), ACS of Alaska, LLC (ACS-AK), and ACS of Fairbanks, LLC (ACS-F), collectively, ACS-LECs, and QuantumShift Communications, Inc. d/b/a vCom Solutions (QuantumShift) submitted for Commission approval a Local Business Resale Agreement (Resale Agreement) between the parties on September 19, 2013. Docket U-13-163 was opened to address this matter.

The resale agreement sets forth the terms, conditions, rates for resale of telecommunications services. Provisions of the agreement include the following:

- (1) The ACS-LECs will make available for resale to QuantumShift all telecommunications services the ACS-LECs provide to retail subscribers that are not telecommunications carriers.
- (2) The ACS-LECs will provide a wholesale discount of 24.62 percent off retail tariff rates to QuantumShift.
- (3) ACS-LECs and QuantumShift will apply a bill and keep compensation arrangement for local traffic.
- (4) The resale agreement will be in effect for a period of three years, and is automatically renewed for successive one-year terms until the agreement is terminated by either party.

The resale agreement was adopted through negotiation and was filed pursuant to Section 252 of the Communications Act of 1934, as amended by the Telecommunications Act of 1996. Under federal law, the Commission must approve or reject a negotiated interconnection agreement within 90 days of submission or the agreement is deemed approved.
